

Thursday, November 3, 2011 MUTS meeting:

Members present: T. Murphy, R. Regina, Sal Ricci, J. Silva, B. Kokot, J. Whitney, T. Littlefield, G. Mason, B. Walkley, C. Cutler, J. Zeleznik.

Motion made to begin meeting @ 8:13p.m. By Club president – Rocco Regina. Call was made to accept prior meeting minutes – all present in favor.

Vice President: G. Mason: no updates at this time.

Fiscal update: report provided by J. Whitney. Present balance at \$14,930.37

Anticipated expenses before 2011 year end: \$800 for Rodrigo Fall keeper training, & \$1,300 for field lining (Jenlo) total of \$2,100 in disbursements. Deposits: 2011 Fall fees \$6015/\$50 for patches – total of \$6065.00
Reconciliation: 12/31/10 \$10,271.85 – 10/31/11 \$14,930.37\$ There was a \$4,658.52 reconciliation difference. Fulton bank will be the new name of the bank holding the MUTS account; routing numbers may change at some point in the future.

MOSA update: by B. Kokot – so far this fall season, there were 7 players/2 coaches issued red cards. In regards to any issues with field dimensions, an individual coach can make the call to not play the scheduled game prior to the start of the game; it will be recorded as a no game. With a game delay, the head referee can give 15 min for the home team, 30 minutes for an away team. Games are to be officiated with 3 referees, no 2 whistle system, and coach can refuse the 2 whistle, once game starts, you cannot change back. Concussion certificates were to be submitted to the state by each club by 10/15. Concussion certificate/F license should be with each coach at all times for games.

Web site: T. Doran discussed user friendly issues with navigating our web site; looking at ways to add more content for each team with their respective information; also discussed having additional training for club members.

Field/maint: C. Cutler & the general membership discussed seeding fields, as well as shifting fields to allow for some rest; communication will be made with the rec dept. For the Spring: shut down fields 7/4/2, repair 8, & extend into 5 (do away with it)...open 1/3/6. A product referred to as ‘Whiskers’, would help mark the corners of the fields; can purchase them via the internet for 50 cents each. Our club will decide to purchase 200 for \$100.

Ref assignor: T. Littlefield reviewed the protocol with games being cancelled & rescheduling. Important that you follow up with her & inform what team you are, & what team you are going against. The earlier the better; beyond the Wednesday of a game week – it will be too late. Season has been good, with few pre-plays; anticipate the Spring having more preplays.

Fundraising: J. Silva disseminated circulars with details involving a club wide raffle: the 50/50 drawing would involve having 300 tickets sold, with \$100 charged for each ticket. The grand prize would be \$10,000....2nd prize \$3000, & third prize \$2,000. Proceeds could net the club approx. \$15k. The Drawing could be held at the Clarksburg Inn coupled with the 1st annual Soccer appreciation night in Feb., 2012. Also discussed raffling off a car.... Discussed ways to involve MUTS with Great Adventure marketing...

Miscellaneous: Coaches shirts have arrived and have all been distributed; if any coach has not received one, contact Jim or Rocco. Sportzone has winter special for MUTS team training & winter leagues. Also offering winter rec leagues and for every MUTS player who participates, Sportzone will donate \$800 to the league. Gym time was

discussed tonight; signup sheets were passed around for each to team sign up. For teams not in attendance, a time was designated. A schedule has been circulated to all via email.
